Just as true, though, is the fact that investors, stakeholders, and others have been looking for opportunities to invest in lawyers, law firms, and the legal industry. One consequence of this interest is the rising implementation of “management service organizations” or “two company models” in which law firms enter into agreements with outside management companies who run most or all of the back-office and other non-lawyer functions of the firm, in exchange for receiving a share of the law firm’s revenues. As expected, this increasingly popular form of monetizing law firms faces a slew of structuring and ethical challenges. 3:45 – 4:45 p.m. <i>Toronto Ballroom III</i>	<p><b><i>Bonus session: Book review of “Lawyer Nation: The Past, Present, and Future of the American Legal Profession”</i></b></p> <p><i>The American legal profession faces significant challenges: the changing nature of work in the wake of the COVID-19 pandemic; calls for greater racial and gender justice; threats to democracy; the inaccessibility of legal services for the majority of Americans; the risk of obsolescence owing to the emergence of new technologies; and the disaffection many lawyers feel toward their work. Ray Brescia provides concrete ideas for transforming law into a field whose services are accessible, egalitarian, and viable in the long term. Further, he addresses how the profession can improve so that the health of its practitioners is not compromised in the process. If the legal profession does not respond to its crises in an effective way, he argues, the dysfunction and unfairness plaguing the legal world will deepen. From white-collar defendants to individuals charged with heinous crimes, the obligations of competent representation can clash with public perception and our personal values. And, then there is also considering the reputational risk to the practitioner and/or their firm. It can be challenging to manage a client while balancing the need to correct misperceptions, while simultaneously addressing the scrutiny, bias and judgment of our peers and the public. What can we do, as ethical advocates, to help manage and shape public opinion without disclosing confidences or just not making things worse?
