10:30 – 11:45 a.m. Chula Vista	<p><i>When the Lawyer Becomes the Source of Evidence: Ethical Duties and Strategies When Client Information is Sought Through Subpoenas, Search Warrants, and Testimony.</i></p> <p><i>When the lawyer becomes the source of evidence, rather than the advocate, a host of ethical minefields emerge. This panel examines the professional responsibility challenges that arise when lawyers and law firms are compelled to disclose client information through subpoenas, search warrants, or court orders, or when counsel becomes a witness in a client-related matter. Panelists will address the intersection of confidentiality, privilege, and compliance with legal process; the ethical duties owed to current and former clients; and practical strategies for navigating law enforcement demands while minimizing privilege waiver and disciplinary exposure. 12:45 – 2:00 p.m. Chula Vista	<p><i>Clear Thinking in a Charged Climate: A Practical Workshop for Lawyers and Ethics Counsel (Wellness)</i></p> <p><i>Political polarization, public distrust, and constant digital noise are making it harder for lawyers to remain focused, effective, and professionally grounded. This workshop cuts through that noise with practical, use-in-the-moment strategies for restoring clarity—strategies you can use yourself and also introduce to clients facing disciplinary issues or other stressful turning points. 2:15 – 3:30 p.m. <i>Chula Vista</i>	<p><i>When One Lawyer’s Problem Becomes Everyone’s: Imputation Across Practice Settings</i></p> <p><i>This panel will explore how rules of professional conduct —particularly Model Rules 1.10, 1.13, and 5.1–5.3—pose markedly different challenges depending on where lawyers practice, their professional backgrounds and roles, and the organizational contexts in which they work. Rather than treating professional obligations as abstract or uniform, the program examines how “imputed” knowledge, conflicts of interest, and supervisory duties actually function across diverse real-world practice settings. Central to its discussion will be how factors such as firm size, resource constraints, organizational structure, client sophistication, and institutional culture shape what “reasonable supervision” and ethical compliance realistically mean in practice. The panel will consider the ethical and practical impact of technology—especially with respect to artificial intelligence (for example, whether it is appropriate to view AI merely as a highly capable virtual paralegal or something more disruptive requiring special oversight protocols). In doing so, the panel will highlight how a one-size-fits-all regulatory model can obscure—not clarify—meaningful ethical expectations and outcomes as well as potential professional liability.</i></p> <p>Charles Davant, Williams & Connolly LLP, Washington, D.C.
