Who We Are

The Association of Professional Responsibility Lawyers ("APRL" pronounced April) is comprised of more than 400 lawyers, law professors and judges holding an interest in lawyers' professional responsibility, legal ethics, legal malpractice, and the evolving law of lawyering, primarily through the application of the rules of lawyer ethics to the practice of law.

The majority of APRL members provide advice to lawyers on legal ethics issues, defend lawyers in discipline matters or civil malpractice cases, act as expert witnesses, teach professional responsibility courses in law schools, or perform ethics-related functions in law firms.

Our Impact

- Public Position on Professional Responsibility and Legal Ethics The Association takes public positions on matters pending before the executive and legislative branches of government. In terms of the judiciary, APRL provides testimony and input before the judiciary and, in appropriate cases, it files amicus curiae briefs. It also furnishes input and opinion relating to legal ethics matters before the American Bar Association and other bar organizations on professional responsibility matters.
